Present were Robert P. Chadeayne Secretary, Jeanne M. Capello Vice Chair, Tara Simmons-Archie, Jason Corwin Registrar, Wally Hudson Republican Party, and Annette Tucker Democratic Party.

Ms. Capello called the Provisional Meeting to order at 10:03 AM EST.

Ms. Capello introduced Tara Simmons-Archie as the temporary member of the board having been duly appointed by the Circuit Court.

Mr. Chadeayne offered a motion to appoint Ms. Jeanne M. Capello to the position of Chair of the Mecklenburg Board of Electors. Motion passed.

The Chair on behalf of the board commended Jason Corwin and Darcell Terry for their work to make our November 6, 2018 election a transparent event in Mecklenburg County. Job well done!

Minutes

Present were Robert P. Chadeayne Secretary, Jeanne M. Capello Chair, Tara Simmons-Archie, Jason Corwin Registrar, Wally Hudson Republican Party, and Annette Tucker Democratic Party.

Ms. Capello called the Canvas Meeting to order at 10:53 AM EST.

Precinct 103 submitted an incident report of a voter falling.

Precinct 201 Missing results tape on SOR. Ann Miller, voter entered provisional ballot into machine and not the envelope that was provided.

Precinct 202 No results tapes on SORs. Tapes were printed but not separated and attached. All were attached to the yellow sheet.

Precinct 203 No record of poll book check-in number on the SORs

Precinct 301 No zero tapes attached to SORs. One zero tape attached to the yellow sheet.

Precinct 302 Envelope 2 contents loaded with wrong items i.e. request for assistance, forfeited absentee ballot, no zero tapes. Envelope 2A missing. Subsequently was found unsealed. Assuming the envelope was unused it was put back in stock.

Precinct 402 No zero-tape attached to SORs. One zero tape was in envelope 2A with the yellow sheet.

Precinct 601 Yellow sheet in envelope 2 not 2A and only one zero tape. No envelope 2A was found.

Precinct 603 Only one zero tape. Ballot record report in envelope 2 (wrong envelope).

Precinct 604 No information in various count boxes on the SORs. Only one zero tape attached to the yellow sheet. Workers sign-in and out time not on form. The chief was called and requested to come into the office to complete the SORs.

Precinct 701 No SORs in envelope 2, all in envelope 2A. Conflict in check-in of Wanda Duckworth and Rhonda Duckworth poll book worker mistake.

Precinct 702 Ballot record report in envelope 2 not 4 as required.

Precinct 801 No zero tapes attached to SORs. One zero tape attached to yellow sheet.

Precinct 803 No zero tapes attached to SORs. One zero tape attached to yellow sheet.

Precinct 901 Incident report. Polling location was not open at 5:00 AM to allow poll workers to set up. Chief had to call for building to be opened. The bathroom was unclean.

Precinct 902 Ballot report in envelope 2 not 4. SORs had only two signatures.

Precinct 999 Jason only printed one zero tape. For the CAP the SOR needs an entry location for manually counted ballots.

A copy of the canvas results is attached. Mecklenburg County had a total of 11,868 votes cast
